During February, there were approximately 1,346 page views on the Perch Base website during 638 sessions by 427 users based on Google Analytics. Approximately 83% of the visits originated in the US, 2% from the United Kingdom, 2% from Canada and the remaining 17% are not specified or widely scattered around the world. Approximately 42% of the visits were from locations within Arizona. The Homepage accounted for the largest (40%) percentage of the visits, exceeding the Glossary (28%), the Sailing Orders page (7%), and the Eternal Patrol page (3%).
